Location: Within the Commission's 100-foot shoreline band jurisdiction, at an undeveloped property located adjacent to a property at 1363 Embarcadero, in the City of Oakland, Alameda County.

Description: To close a gap on the San Francisco Bay Trail at an undeveloped site, conduct the following activities:

- (1) Construct, use and maintain in-kind a 12-foot-wide, approximately 860-foot-long asphalt path with a wood edge rail, a five-foot-wide decomposed granite shoulder, an adjacent three-foot-wide swale, and painted wayfinding markers;

- (2) At the path entrance from Embarcadero, remove a 12-foot-wide section of existing fence and a tree at the path entrance; construct, use and maintain in-kind approximately 423 square feet of paving; and install, use and maintain in-kind two bollards and informational signage at the path entrance;
- (3) Install, use and maintain in-kind an approximately 215-foot-long, six-foot-tall fence located landward of the path; and
- (4) Install, use and maintain in-kind three salvaged dock cleats to be used as ornamental features.
