**SUBJECT:** **Background information for the Briefing on the Bay Plan Amendment to Address Environmental Justice and Social Equity, Bay Plan Amendment No. 2-17**  
(For Commission consideration on December 6, 2018)

## Summary

On October 6, 2016, during the fourth workshop of the Commission's series of Public Workshops on Rising Sea Level, the Commission voted to approve eight recommended adaptation actions, including consideration of whether and how to change BCDC's existing laws, policies and regulations to more fully consider the local and regional impacts of rising sea levels in permitting and decision-making processes as needed. The subsequent workshops further explored and discussed the potential actions, with a particular focus on possible Bay Plan amendments. Staff provided a briefing to the Commission with a timeline for six proposed amendments (attached), among other actions, and on July 20, 2017 the Commission voted to initiate the first two Bay Plan Amendments: Fill for Habitat and Environmental Justice. At the Commission meeting on December 6, 2018, BCDC staff will present on the progress of the Environmental Justice and Social Equity Amendment.
