BCDC,

As predicted at Thursday's meeting of the **BCDC Enforcement Committee**, there is an increasing number of RVs parked full-time in the **East Parking Lot at Union Point Park**.

Least we forget, this parking lot had been totally overrun with RVs in early 2019.

There was a major fire in which many vehicles were destroyed.

A young child was also shot.

After the resolution of a federal injunction, the City of Oakland cleared this lot in August of 2019 and it was deemed a formal **"Closure Area"**.

Nevertheless, there has been no enforcement of clearly posted parking ordinances and full-time campers are returning.

Does it make any sense to endlessly go through this same cycle?

Without proper attention this situation will only continue to get worse.

Please share this information with the full BCDC Commission as this seems to be the only impetus for the City of Oakland to act responsibly.
