**Project**

**Description:** The project is to construct a 10,625-square-foot agricultural accessory structure on a 29-acre parcel off of Chadbourne Road, one mile south of the City of Fairfield, in unincorporated Solano County and within the Secondary Management Area of the Suisun Marsh. The purpose of the proposed structure is to store hay grown on the property. The proposed structure would not be sited near any marsh or wetland habitat.

Solano County found the proposed project to be consistent with the Suisun Marsh Preservation Act and its Local Protection Program (LPP) for the Marsh because the proposed agricultural accessory structure is incidental to the existing dryland farming operation and consistent with all relevant policies of the Suisun Marsh Local Protection Program.

On October 20, 2016, the Solano County Zoning Administrator granted a Marsh Development Permit for the proposed project in Solano County's portion of the Suisun Marsh Secondary Management Area. Final Notice of County approval of the project was received at the Commission's office on November 7, 2016. Anyone who wishes to file an appeal with BCDC on the County decision must do so by 5:00 p.m. on December 8, 2016, at the Commission's office.
