Yesterday a seven year old child was shot while playing at the homeless encampment at Union Point Park.

To my knowledge the person responsible for this shooting has not been apprehended.

This is yet the latest incident of violence attributed to the illegal homeless encampments.

I realize that the City of Oakland is in the midst of a legal process which will hopefully allow a thorough cleanup of the park and established a permanent **CLOSURE STATUS** to prevent any further reoccupation.

Can you provide an update on this process?

Marina tenants and staff are justifiably concerned about their safety.
