**Bagley-Keene Open Meeting Act**

As a formal advisory body to a state agency, the Bay Adapt Local Electeds Regional Task Force is governed by the Bagley-Keene Open Meeting Act which requires the Bay Adapt Local Electeds Regional Task Force to: (1) publish an agenda at least ten days in advance of any meeting; and (2) describe specifically in that agenda the items to be transacted or discussed. Public notices of Bay Adapt Local Electeds Regional Task Force meetings and staff reports (as applicable) dealing with matters on the meeting agendas can be found on [BCDC's website](#). Simply access Bay Adapt Local Electeds Regional Task Force Meetings under the "Public Meetings" tab on the website and select the date of the meeting.

**How to Provide Comments and Comment Time Limits**

Pursuant to state law, the Bay Adapt Local Electeds Regional Task Force is currently conducting its public meetings in a "hybrid" fashion. Each meeting notice will specify (1) where the meeting is being primarily held physically, (2) the ZOOM virtual meeting link. If you would like to comment at the beginning of the meeting or on an item scheduled for public discussion, you may do so in one of three ways: (1) being present at the primary physical (2) emailing comments in advance to [public comment](#) until 10 a.m. on the day of the meeting; and (3) participating via ZOOM during the meeting.

If you plan to participate through ZOOM, please use your ZOOM-enabled device and click on the "raise your hand" button, and then wait to speak until called upon. If you are using a telephone to call into the meeting, select \*6 to unmute your phone and you will then be able to speak. We ask that everyone use the mute button when not speaking. It is also important that you not put your phone on hold. Each speaker may be limited to a maximum of three minutes or less at the discretion of the Chair during the public comment period depending on the volume of persons intending to provide public comment. Any speakers who exceed the time limits or interfere with the meeting may be muted by the Chair. It is strongly recommended that public comments be submitted in writing so they can be distributed to all Bay Adapt Local Electeds Regional Task Force members in advance of the meeting for review. You are encouraged to submit written comments of any length and detailed information to the staff prior to the meeting at the email address above, which will be distributed to the Bay Adapt Local Electeds Regional Task Force members.

If you have any questions concerning an item on the agenda, would like to receive notice of future hearings, or access staff reports related to the item, please contact the staff member whose name, email address and direct phone number are indicated in parenthesis at the end of the agenda item.

**Campaign Contributions**

State law requires Bay Adapt Local Electeds Regional Task Force members to disqualify themselves from voting on any matter if they have received a campaign contribution from an interested party within the past 12 months. If you intend to speak on any hearing item, please indicate in your testimony if you have made campaign contributions in excess of \$250 to any Bay Adapt Local Electeds Regional Task Force member within the last year, and if so, to which Bay Adapt Local Electeds Regional Task Force member(s) you have contributed. Additional legal requirements govern contributions by applicants and other interested parties and establish criteria for Bay Adapt Local Electeds Regional Task Force member conflicts of interest. Please consult with the staff counsel if you have any questions about the rules that pertain to campaign contributions or conflicts of interest.
