Crockett Cogeneration Plant (Plant), a 240-megawatt natural gas-fired combustion gas turbine electrical power generating plant located in an

unincorporated area of Crockett, Contra Costa County. The project will involve filling voids in the seawall and reconstructing and expanding a rock riprap

revetment. The revetment will incorporate ECOncrete blocks to increase habitat diversity of the revetment. As the project will result in Bay fill, the applicant would compensate by removing approximately 30 square-feet of creosote

treated wood piles and debris near the project site.
